Since 2013, PostFinance has been an independent public limited company under private law, domiciled in Berne (Switzerland) and wholly owned by Swiss Post Ltd. The equity capital is fully paid in and is wholly owned by Swiss Post Ltd. PostFinance was granted a licence to operate as a bank and securities dealer on 26 June 2013 and is subject to regulation by the Swiss Financial Market Supervisory Authority (FINMA).

Legal reporting

PostFinance Ltd is legally obliged to publish a detailed annual and interim report on its business activities. This reporting also contains information that is required to maintain cross-border relationships with other financial institutions. For this reason, PostFinance does not generally answer individual AML/KYC Questionnaires.

Legal ownership of PostFinance Ltd

As per the information set out in our annual report, PostFinance Ltd is wholly owned by Swiss Post Ltd (Schweizerische Post AG). We do not have other shareholders at present and PostFinance Ltd is not listed on any stock exchange. Swiss Post Ltd itself is wholly owned by the Swiss Confederation.
