Sales remuneration	Only funds without sales remuneration are used in e-asset management.
Minimum investment amount	A minimum investment amount of CHF 5,000 applies when subscribing to and using e-asset management.
Minimum investment amount (follow-up investment)	From CHF 0 as a one-time transfer or via the "standing transfer order" function as a saving plan. Investment amounts of up to CHF 500 are generally invested as part of the next rebalancing.
Redemptions	Possible from CHF 500. The minimum investment amount of CHF 5,000 must remain in e-asset management after redemption. This means redemptions can be made in e-asset management from investments of CHF 5,500 or more.
Securities delivery to third-party banks	Not possible
