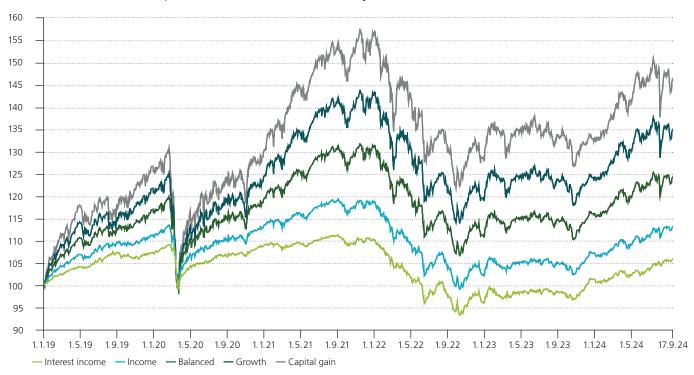
Focus Sustainability

This investment focus takes into account environmental, social, and governance (ESG) criteria relating to the environment, society and responsible corporate management.

The aim of the sustainability focus is to invest more socially and ecologically. For environmental reasons, we avoid investments in gold in this focus. However, we do not view sustainability as solely a question of protecting the environment, but also take into account additional ESG investment criteria with regard to society and responsible corporate management when selecting instruments. In the sustainability focus, the domestic market is taken more into account than the rest of the world. In addition to Swiss bonds and shares, bonds and shares from all over the world are added for diversification. Investments are also made in Swiss real estate.
